

CODICIL

1. SCOPE OF THIS CODICIL

- (c) In the event of the Contemporary Art Society being unable to make such a presentation then the Contemporary Art Society may sell the work(s) of art and the net sale proceeds shall be applied by the trustees of the Contemporary Art Society to further the general purposes of the Contemporary Art Society.
- (d) The receipt of the treasurer or an appropriate officer of the Contemporary Art Society shall be a complete discharge to my Executors in respect of the transfer of the work(s) of art.
- (e) If the Contemporary Art Society ceases to exist, changes its name, or enters into insolvent liquidation before the time that this gift takes effect in possession, the gift shall instead be paid to such charity as my Executors decide, having regard to the objects that were intended to benefit."

OR:

"[PRECEDING CLAUSE NUMBER]A:

- (a) [I give to the Contemporary Art Society (registered charity number 208178 of 59 Central Street, London EC1V 3AF) the sum of £XX as an unrestricted gift for its general purposes.] **OR** [I give to the Contemporary Art Society (registered charity number 208178 of 59 Central Street, London EC1V 3AF) XX% of the residue of my estate as an unrestricted gift for its general purposes.]
- (b) The receipt of the treasurer or an appropriate officer of the Contemporary Art Society shall be a complete discharge to my executors in respect of the payment of this gift."
